The National Office did a survey and the consensus from majority of demo jump organizers was they do not want the increase coverage as the price increase is not worth it. Insurance policy remains at 3M coverage.

5. Parachutisme Victoriaville legal fees invoice:

CSPA received a legal fee invoice in the amount of \$258.69 in their on-going legal case. BoD discussed and approved.

6. Insurance policies:

The new insurance policies for the National Office, Directors & Officer's insurance and 3M Third Party Liability.

Policies were all approved by BoD.

The 3M Third Party Liability insurance policy will now include non-owned aircraft damage claims, for damage sustained in flight by a skydiver. The liability limit on this policy will be \$50,000 to match that of the USPA policy. This will ensure that CSPA jumpers are not turned away at USPA dropzones. Any access to the aircraft damage portion of the policy will require the jumper to pay the \$2500 deductible.

The Office reminded BoD members when submitting expense claim back-up, it is mandatory that the tax break-down accompany their expense claim or reimbursement will not be paid.
